EXECUTIVE ACCOMPLISHMENTS

The YCPE's Executive members have had an incredible year and continue to make valuable contributions to the field of practical ethics. Here are just a few of our accomplishments over the past few months.

Professor Naomi Couto has successfully received Tenure and Promotion. The good news from the President's Office came on May 6, 2016!

Professor Couto will also leave us this academic year to head out on sabbatical. Professor Couto has been invited to join the University of Keele in Staffordshire, England as a visiting scholar. She will be working on a new research project entitled, "Education and Utopia: Neoliberalism, the Democratic Deficit, and the Destruction of the Citizen." The project aims to explore the possibility of the creation of an educational system and educational institution able to socialize citizens who are committed to democratic change and production of a society that values equality, freedom, and hope. The grounding belief is that this is an important issue in contemporary society. If hope and change are likely to emerge from anywhere in our world, they will come from children and youth through their engagement with the education system, which shapes their orientation towards the world. Professor Couto's hope is to bring some of these findings into the realm of *ethics and governance* courses that could be taught at the elementary and high school levels in Canada.

Professor Peter Constantinou has been awarded the York University President's University-Wide Teaching Award in the Contract and Adjunct Faculty category. Professor Constantinou's award letter states, "You are clearly a creative teacher who develops in students a capacity for critical thinking and a passion for public service".... and... "It is evident that the concepts that your philosophy of teaching rests on respect, enthusiasm and experiential education – are successfully implemented in your teaching practice."

Professor Constantinou has been a

valued faculty member at York University for many years, but this year his status has also been converted to tenure-track under the York University Faculty Association (YUFA) conversion program.

But the good news does not end there for **Professor Constantinou** - in August of 2015 he was also appointed to be the Academic Director of the Ontario Legislature Internship Programme.

Professor Philip MacEwen

worked with Kira Tomsons of the Department of Philosophy, Douglas College, to co-organize the 2016 Conference of the Canadian Society for the Study of Practical Ethics at the Congress of the Humanities and Social Sciences, May 28-30, held at the University of Calgary. Professor MacEwen gave a paper on the ethics of drones at the Conference.

While completing his PhD in government ethics law at Osgoode Hall Law School, **Ian Stedman** has also been appointed to the research ethics board at Toronto's SickKids Hospital as a legal member. Ian will also be teaching the Legal Process course for two section of Osgoode's incoming first year law students.



WORKING TOGETHER

University Professor Emeritus Ronald Pearlman of York's Faculty of Science & Engineering will give a talk about the legal, ethical and many scientific implications of the emerging gene-editing technology known as CRISPR. This talk will be held at Osgoode Hall Law School and will be promoted university-wide!

The York Collegium for Practical Ethics will be working together with the York Centre for Public Policy and Law throughout 2016-2017 in order to bring exciting and engaging talks like this one to McLaughlin College, Osgoode Hall Law School and the broader York University community!

With the help of Professor and YCPPL Director Richard Haigh at Osgoode Hall Law School, the YCPE and YCPPL have begun planning this first cosponsored event to take place in November 2016.

LUNCH TALK SERIES

THE COLLEGIUM'S MANDATE

The York Collegium for Practical Ethics organizes a seminar series that addresses issues related to practical ethics on a monthly basis. It may also work with other organizations to organize workshops and conferences on practical ethics.

One of the Collegium's goals is to raise awareness of practical ethics and to facilitate the integration of ethics into the everyday life of the surrounding communities, including businesses, government, and the professions. The forerunner of the Collegium was the York Centre for Practical Ethics, which operated from 1994 to 2013.

The Centre was established in 1994 to further research in the field of practical ethics and to support the teaching of practical ethics at York University.

YCPE has an executive that reports to its members and affiliates and to the Master of McLaughlin College. As of August 1, 2016, the executive consists of Philip MacEwen, Naomi Couto, Ian Greene, Peter Constantinou, Gregory Levine, and Ian Stedman.
